**Note: \*Special Case Option** may be considered by the Architectural Committee when: Adjoining homeowners in a particular townhome building all agree upon a “premium or custom clad color” that matches their townhome trim color.

-OR-

In a case where the windows of a townhome in a particular building have already been replaced with an approved “premium or custom clad color”, and all adjoining townhome owners wish to use the same clad color to keep their building esthetically consistent.

**IMPORTANT NOTES:**

- Acceptable window and patio door replacements:  
Wood aluminum clad windows and patio doors, Anderson wood vinyl clad windows and patio doors, Marvin Integrity windows and patio doors.
- VINYL windows and patio doors and **ALL WOOD** windows and patio doors are not acceptable for window and door replacements.
- SASH-ONLY & INSERT REPLACEMENT windows are not acceptable.
- Aluminum and vinyl trim fillers are not allowed. Must use cedar wood trim fillers to be painted the same as existing trim color.
- Window and patio door replacements must conform to existing rough openings.
- Windows must meet local egress codes for fire evacuation.
- Other wood aluminum clad window and patio door manufacturers may be acceptable. Submit manufacturer’s name, specifications, and color chip with Window & Patio Door Request Form for review.
- Special Case Option/Upgrading to Premium or Custom Colors: It is recommended that all windows be changed when using a premium or custom color to assure availability, as manufacturers do discontinue some special colors over periods of time.
- No construction materials are to be placed or stored on streets. Dumpsters must be placed on driveway. (Placing dumpsters on street is prohibited.) Dumpsters should be placed, by contractor, on plywood or planking to protect driveway.

**CERTIFICATE OF INSURANCE:** Your contractor must supply you with a certificate of insurance, stating that you (as homeowner) and the Crystal Tree Homeowners' Association are named as additional insured. A copy of this certificate must be submitted along with your Request Form.
